Can Bollinger Bands Predict Market Volatility?



"Cardano was initially released to the public in 2017. That year, IOHK partnered with the University of Edinburgh to launch the Blockchain Technology Laboratory. The lab had six post-doctoral and professorial positions with up to 35 jobs created in total, and was led by Aggelos Kiayias, developer of the Ouroboros protocol. Cardano reached a market cap of \$77 billion in May 2021, which was the fourth highest for a cryptocurrency at that time. Advertising agency MBLM ranked Cardano 26th for brand intimacy out of 600 brands in August 2022, in between Ford and Nestlé and the highest rank for a cryptocurrency. Citing an MBLM partner, advertising industry magazine Ad Age said Cardano's high ranking "can likely be chalked up to the gambling element of crypto"."


How to Identify Overbought Conditions with RSI?



How Does Fear and Greed Index Affect Your Technical Decisions?


In the constantly changing landscape of digital markets, precision becomes a tool and timing a craft.

Despite the name, which has come to describe many of the fungible blockchain tokens that have been created, cryptocurrencies are not considered to be currencies in the traditional sense, and varying legal treatments have been applied to them in various jurisdictions, including classification as commodities, securities, and currencies. Cryptocurrencies are generally viewed as a distinct asset class in practice. The first cryptocurrency was bitcoin, which was first released as open-source software in 2009. As of June 2023, there were more than 25,000 other cryptocurrencies in the marketplace, of which more than 40 had a market capitalization exceeding \$1 billion. As of April 2025, the cryptocurrency market capitalization was already estimated at \$2.76 trillion."

Can Support and Resistance Be Used on Any Timeframe?

"As of July 2021, Tether is tied to half of all bitcoin trades. Also in 2021, the company was fined by the CFTC for only maintaining full reserves during 27.6% of the days in the period from 2016 to 2018 as well as for failing to present audits showing sufficient asset reserves. In May 2022, Tether launched its MXNT token pegged to Mexico's peso as a "testing ground" in Latin America. Also in 2022, Tether remained strong during a time when several once-reputable companies in crypto and banking collapsed. Tether's nearest competitor, Circle, experienced a faltered growth to the point where its \$24 billion of USDC was worth barely more than a quarter of Tether's stash. In October 2023, Paolo Ardoino, the chief technology officer for Tether, was promoted to CEO."
